Free EPS masterclass training **EPS Factsheet for prescribers**

To help dispensers to get the most out of EPS, new masterclass training is available for all staff working in community pharmacy and for dispensing appliance contractors (DACs). This includes counter staff, dispensing technicians, pharmacists and locums. If you are new to EPS or an experienced user, these masterclasses are essential for everyone.

The free masterclass training is being organised by the EPS Team at the Health and Social Care Information Centre (HSCIC), in conjunction with Local Pharmaceutical Committees (LPCs), dispensing system suppliers and NHS Business Services Authority (NHSBSA).

Over 800 evening masterclasses will be held throughout England, from late September 2015 until 30 June 2016.

What's included in the masterclass training?

- 1. Dispensing system training tailored specifically to your PMR system and covering how to use EPS Release 2.
- 2. Business process change and how to get the best out of EPS, including business continuity.
- 3. A Claiming and Endorsing Masterclass presented by the NHS Business Services Authority.

At least one event for every PMR system will be held in each local LPC area. The EPS Team will host at least seven events in each LPC area.

The masterclass training has been endorsed by the Centre for Pharmacy Postgraduate Education and attendance counts towards your continued professional development.

All staff working in community pharmacy or for DACs are encouraged to attend a masterclass event, to help them to get the most from EPS and to prepare for the future of EPS, when it becomes the default prescribing process.

This is a unique opportunity to undertake free EPS training specific to your PMR system, as well as to gain an advanced level of understanding of how to make the EPS system work for you and how to manage electronic claiming and endorsing correctly.

Food will be provided on the evening and attendees will receive a supporting information pack. There will also be ample opportunity to ask questions of the experts delivering the sessions. Booking on the masterclass training means you agree to receive EPS and SCR bulletins from the HSCIC and relevant business to business communications from the NHSBSA.
